Executive sessions are not open to the public. No final legal action will be taken in executive session, and any final vote or decision on such matters will occur during the public meeting. The Governing Body's attorney may participate in person or by telephone.

Copies of background materials pertaining to agenda items, excluding materials related to executive sessions or otherwise confidential by law, are available for public review at the meeting location prior to the Governing Body meeting.
